China, Germany and U.S. are now the biggest paper exporters worldwide




China and Indonesia are the top 2 paper exporters in APAC

China is a more global paper trader while Indonesia is more concentrated



Logistics – impact CHN/IDN








Global container transportation market has been increasingly volatile since covid




Red sea shipping crisis led to a 4000 miles longer journey



- **17000 ships** go through the Suez Canal each year
- 12% of annual global trade passes through the Red Sea
- 1 trillion USD worth of goods
- 4000 miles longer distance
- 30% longer time

2 Pulp price and its volatility goes up





- Indonesia kept fine paper net export stable at high level
- By product, growth in China export mainly comes from graphic paper
- By country, growth in China mainly comes from UAE/Saudi(106kt), Vietnam(103kt), Turkey(90kt) and India (86kt)

EU Deforestation Regulation (EUDR)



- Objective of the regulation is to halt and reverse EU-driven global deforestation based on mandatory due diligence
- Entered into force on 29 June 2023 → Transition period of 18 months until 30 December 2024
- Prohibition to place relevant products on the EU market or export them unless
 - They are deforestation free
 - They have been produced in accordance with the relevant legislation of the country of production
 - They are covered by a due diligence statement
- · Commodities covered are cattle, cocoa, coffee, palm oil, rubber, soya and wood
